

Client Relationship Summary – February 14, 2024

Wealthspring Capital LLC ("we" or "us") is registered with the Securities and Exchange Commission (SEC) as an investment adviser. Brokerage and investment advisory services and fees differ, and it is important for you to understand the differences.

Free and simple tools are available to research firms and financial professionals at <u>Investor.gov/CRS</u>, which also provides educational materials about broker-dealers, investment advisers, and investing.

What investment services and advice can you provide me?

We offer investment advisory services to retail investors. More specifically, we offer two main strategies: 1) investments in special purpose acquisition companies ("SPACs") and 2) investments in structured notes. WSC also manages accounts that are invested exclusively in U.S. Treasury Bills. Ongoing monitoring of these investments is included as part of our standard investment advisory services. WSC also provides investment management services to one private fund. This private fund has an investment strategy that does not overlap with the main strategies pursued by WSC.

We have investment discretion over client accounts. This means that we buy and sell investments in a client's account, without asking the client in advance. Any client requests to tailor an investment strategy to the individual needs of the client are considered on a case-by-case basis and would typically be documented in a client's Investment Guidelines.

We typically require an account minimum of \$250,000 in the SPAC strategy and \$500,000 in the structured notes strategy and accounts invested exclusively in U.S. Treasury Bills, which we may waive in our discretion, but will typically never be less than a minimum of \$100,000.

What fees will I pay?

We charge you an advisory fee at the end of each quarter (in arrears). The fee is typically based on an average of the daily balance in the client's account throughout the billing quarter. In certain cases, for the structured notes strategy, the fee is based on an average of the month-end balance in the client's account throughout the billing quarter. In addition, indirect clients in the structured notes strategy that are obtained via sub-advisory relationships are subject to a termination fee if the account is terminated prior to the first anniversary of the establishment of the account. This means that the more assets there are in your advisory account, the more you will pay to us in fees. We therefore have an incentive to encourage you to increase the assets in your advisory account.

Although not offered to new clients, some existing qualified clients pay a quarterly performance fee based on capital appreciation in lieu of the asset-based fee. For performance-based fee arrangements, we make more money the better your investment returns are, so we have an incentive to invest in riskier investments due to the higher risk/higher reward attributes.

You will also pay other fees and costs related to our advisory services and investments in addition to our advisory fee, that you will pay directly or indirectly. Those fees and expenses include, but are not limited to, securities transaction fees, custodian fees, mutual fund fees, and wire transfer fees. If you own an investment product such as a mutual fund or ETF, you will also bear the fees and costs charged by such investment product. With respect



to sub-advisory relationships with third-party investment advisers, the underlying clients (i.e., "indirect clients") typically pay a fee to WSC as well as to their third-party investment adviser. These fees are separate and distinct from the fees and expenses charged by WSC and WSC does not receive any portion of these other fees.

You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

Questions to ask us:

✓ Help me understand how these fees and costs might affect my investments. If I give you \$10,000 to invest, how much will go to fees and costs, and how much will be invested for me?

What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here is an example to help you understand what this means:

- Our firm manages accounts that are billed on performance-based fees and those that are not. Managing both kinds of accounts at the same time presents a conflict of interest because our firm has an incentive to favor accounts for which our firm receives a performance-based fee.

Questions to ask us:

✓ How might your conflicts of interest affect me, and how will you address them?

How do your financial professionals make money?

Our financial professionals are paid a salary based on appropriate market rates and bonus based on the overall success of the firm and individual qualitative performance goals. Certain financial professionals are also shareholders of the firm, who stand to receive a share of the firm's profits. Financial professionals are therefore incentivized to encourage you to increase the assets in your account.
